Accreditation - The ranking system

Budget allocation - the ranking system in KA121 projects

Every year accredited organisations will be ranked on the basis of:

- Previous performances
- Characteristics of their projects:
 - Involvement of participants with **fewer opportunities**: at least 20% out of total participants in mobility activities
 - Implementing **long-term learning mobility** of learners: at least 20% out of total participants in mobility activities
 - Involvement of participants in **blended mobility** activities: at least 5% out of total participants in mobility activities
 - Participants using **green means of travel**: at least 5% out of total participants in mobility activities

Accreditation - BUDGET ALLOCATION

The funds are allocated according to the ranking; the types of mobility requested and the past performances



KA122: Definition of destinations and numbers of people involved in mobility in the application form. Budget automatically calculated.KA121: The budget is firstly allocated and mobilities flows are planned accordingly in a second phase.

ORGANISATIONAL SUPPORT: reimbursement for management activities: administration, preparation of participants, monitoring, preparation of participants, dissemination, quality control, internal communication.)

TRAVEL COSTS

INDIVIDUAL SUPPORT: accommodation, food, insurance, local transport

SPECIAL COSTS: participation of people with disabilities

EXCEPTIONAL COSTS: visa and bank guarantee (only for private organisations)

INCLUSION SUPPORT: top-up of the organisational support budget for organisation of mobilities for people with special needs - fewer opportun.

COURSE FEE: for participating in training courses abroad (max 10 days)



KEY ACTION 1 PROJECTS BUDGET

ORGANISATIONAL SUPPORT

350 EUR per participant in short-term learning mobility of pupils and in staff mobility;

500 EUR per participant in long-term learning mobility of pupils

100 EUR per participants training courses, invited experts and exchange of pupils, invited expert, hosted teacher or educator in training.

Additional organisational support to organise mobilities for participants with special needs or fewer opportunities.

100 EUR per participant





KEY ACTION 1 PROJECTS BUDGET

COURSE FEE

Budget for covering the fee for participating in training courses abroad

80 EUR for participant/day

*every participant can receive a maximum grant of 800 EUR (10 days)





KEY ACTION 1 PROJECTS BUDGET

UNIT COSTS

Fixed sum calculated on the basis of the number of participants.

E.g. TRAVEL COSTS 275 EUR x 10 PAX = 2.750 EUR

REAL COSTS

Reimbursement of real costs on the basis of the invoices presented to the national agency. An estimate of the expenses must be provided in the application form

E.g. SPECIAL NEEDS 100% of real costs

SPECIAL COSTS

Costs related to the participation of people with disability or fewer opportunities

<u>100% of eligible costs</u>

EXCEPTIONAL COSTS

Costs related to the bank guarantee

Expensive travel costs for participants and accompanying persons that cannot be covered under the category "travel costs" due to geographical remoteness or other barriers.

Visas and expenses related to visas, residence permits, vaccinations, medical certifications.

80% of eligible costs

Operating Environment

Description of the state of the art and all those elements that represent our organisation:

- Story
- Training courses
- Previous experiences
- Need Analysis
- Context Analysis
- Stakeholder organisations
- Laws or relevant policies
- Internal team







Vision

The vision describes how an organisation sees the future. It is a values-based statement and can also be particularly ambitious.

It serves to give the reader an idea of how the organisation approaches the realisation of its strategic goals.

E.g. Contribute to the development of a European society where citizens participate actively and in compliance with the law.







Mission

The mission answers the questions "why does my organisation operate?"; "for what purpose does my organisation exist?"

The mission describes how the vision is realised

E.g. provide training programmes for young people aimed at acquiring skills useful for participating in society and entering the world of work.







Objectives

They are defined on the basis of all the previous elements, in particular the needs analysis in the operating environment

They are the strategic objectives to be realised in the international sphere, they therefore envisage a change from the initial situation

They must be realistic and in a number congruent with the analysis carried out in the previous sections







The action plan

It sets out the actions to be taken to achieve the established objectives

Each action must be linked to one or more objectives

Participation in Erasmus+ calls is necessary but other other initiatives are very welcome (e.g. online, co-financed or self-financed activities)





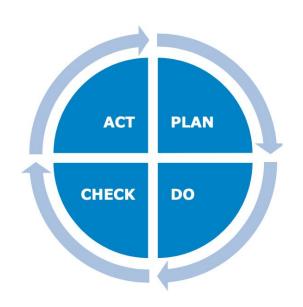


Quality control

The strategy must also include procedures for monitoring the achievement of the objectives

Each strategic objective must be accompanied by one or more indicators

Through the strategy makes it is possible to collect long-term data and demonstrate the impacts of internationalisation on the organisation and target groups

1 - RELEVANCE - MAX 10 POINTS

The extent to which:

The applicant's **profile**, **experience**, activities and target population of learners are relevant for the field of the application, the objectives of this Call, and the type of application (individual organisation or a consortium coordinator)

In addition, for consortium coordinators:

- the profile of the planned consortium members is relevant for the purpose and objectives of the consortium as defined in the application, for the field of the application and the objectives of this Call
- the creation of the consortium brings a clear added value for its members in terms of the objectives of this Call



2 - ERASMUS PLAN: **OBJECTIVES** - MAX 40 POINTS

The extent to which:

- the plan of activities is in line with the objectives of the call
- the objectives meet the explained **needs** and are clearly set out and concrete.
- the objectives and timeframe are **realistic** and sufficiently ambitious to achieve a positive impact for the organisation (or consortium)
- the measures proposed to **monitor and evaluate** the progress of the objectives are appropriate and concrete

If the lead partner has attached an **internationalisation strategy**: there is a clear correlation between the stated objectives and the content of the attached document.

3 - ERASMUS PLAN: ACTIVITIES - MAX 20 POINTS

To what extent:

- the proposed **number of participants** in mobility activities is **proportionate** to the size and experience of the applicant organisation. For consortium coordinators, the planned size of the consortium will be taken into account
- the proposed number of participants in the mobility activities is realistic and appropriate to the objectives set
- the **profiles** of the planned participants are **relevant** to the Erasmus target area
- whether it is intended to organise mobility activities for students with **fewer opportunities**





4 - ERASMUS PLAN: QUALITY STANDARD - MAX 30 POINTS

To what extent:

- the lead partner has proposed concrete ways to **contribute to the basic principles of Erasmus** accreditation described in the Erasmus Quality Standards
- the lead partner has proposed a **distribution of tasks** in line with the Erasmus Quality Standards
- the lead partner has allocated adequate **resources to manage** the programme activities according to the Erasmus Quality Standards
- there is appropriate **staff involvement** within the lead organisation

EXERCISE 2: PROBLEM TREE

Context: You are a management team (managers, teachers) of a school with different problems and needs concerning different targets (students, teachers, school):

The students at our high school are facing significant challenges in developing their foreign language skills. There is a noticeable lack of interest among students in language subjects, and they struggle to grasp them effectively. Currently, only 10% of our curriculum is dedicated to English language instruction, which is far from sufficient. Moreover, our language teachers seem to lack motivation and are in need of updated training and professional development.

Additionally, non-language teachers exclusively teach their subjects in their mother language and lack the necessary skills for teaching in other languages. This approach hampers our students' ability to acquire language skills alongside their regular coursework, which is a growing requirement in today's job market where language proficiency is often combined with specific professional skills.

- 1. Starting from the indicated context, identify among the needs and problems described those on which to focus with this project;
- 2. Identify a common and shared Central Problem "at the centre" of the needs to be met;
- 3. Analyse and relate the problem, the effects and the causes;
- 4. Structure a simple but coherent problem tree.



EXERCISE 3: IDENTIFICATION, OBJECTIVE TREE AND ACTIVITIES

- 1. Transform the problem tree into a objectives tree
- 2. Transform each problem into a "positive": the Central Problem into a Specific Objective
- 3. Formulate objectives (general and specific) and expected results. Structure an objective tree
- 4. Define the activities for each expected result
